FULL TERM OF OFFICE: JULY 1, 2018 TO JUNE 30, 2021

The Declaration of Candidacy/Sponsors Certificate and the Candidate's Statement of Qualifications forms will be furnished by the Candidate Filing Section of the Registrar of Voters Office located at 44 N. San Joaquin Street, Suite 350, Stockton, CA. The Candidate Statement is designed to acquaint the General Members with a candidate's qualification for the office.

Candidates must be **General Members** of the SAN JOAQUIN COUNTY EMPLOYEES' RETIREMENT ASSOCIATION (other than a safety, deferred or retired member).

The Sponsors Certificate must be signed by not less than 15 and no more than 25 **General Members** eligible to vote in the election. The Registrar of Voters shall certify as to the number of qualified sponsors. Monday, April 9, 2018                      The CHIEF EXECUTIVE OFFICER shall furnish the Registrar of Voters Office with a certified list of all general members of the Association entitled to vote in the election, as of **March 31, 2018**.

Monday, April 16, 2018                      First day to obtain and file DECLARATION OF CANDIDACY and the  
(Legal date: Sun. April 15, 2018)              CANDIDATE'S STATEMENT OF QUALIFICATIONS in the Registrar of Voters Office. (65 days prior to the election).

Friday, May 4, 2018                              Last day to file DECLARATION OF CANDIDACY and CANDIDATE'S  
(Legal date: Sat. May 5, 2018)                      STATEMENT OF QUALIFICATIONS in the Registrar of Voters Office.  
(45 days prior to the election).

Friday, May 25, 2018                              The Chief Executive Officer shall furnish the Registrar of Voters Office with a final voter eligibility list.

Monday, June 4, 2018                              REGISTRAR OF VOTERS Office shall prepare and mail the ballots and the Candidate's Statement of Qualifications to each eligible voter. No later than 15 days prior to the election).

PLEASE NOTE:                                      Only the voter may ask for and receive a duplicate ballot by completing a form provided by the Registrar of Voters Office.

Monday, June 18, 2018                              **LAST DAY TO RETURN BALLOTS.** All ballots must be returned to the REGISTRAR OF VOTERS OFFICE, 44 N. SAN JOAQUIN ST, SUITE 350, no later than 5:00 P.M. on this date. All envelopes containing ballots **MUST BE SIGNED** by the voting member.

Tuesday, June 19, 2018                              ELECTION DAY: The Registrar of Voters shall start the Official Canvass of the ballots. Upon completion of the Official Canvass the Registrar of Voters shall certify the results of the election to the Board of Supervisors of the County of San Joaquin.
